Menetapkan :

- PERTAMA** : Mengesahkan: "Protokol Pertukaran Barang2 antara Republik Indonesia dan Republik Federasi Sosialis Yugoslavia untuk tahun 1967", dalam rangka pelaksanaan untuk periode tahun 1967 dari Persetujuan Kerjasama Ekonomi dan Perdagangan djangka pandjang tertanggal 19 Djanuari 1965, sebagaimana ditentukan dalam paragraf ke-6 Protokol tersebut.

P R O T O C O L

on the exchange of goods between the Republic of Indonesia and the Socialist Federal Republic of Yugoslavia for the year 1967.

During the discussions on economic cooperation in Beograd from September 16, till September 29, 1966, the Delegations of the Government of the Republic of Indonesia and the Government of the Socialist Federal Republic of Yugoslavia, noting with satisfaction the cordial relations existing between the two countries and the close cooperation established in various field of activities and being desirous to further promote the mutual economic relations and trade in connection with article 5 of the Agreement of Economic Cooperation and Long Term Trade Agreement of January 19, 1965 have agreed the following :

1. The exchange of goods for the year 1967 will be carried out on the basis of List "A" and "B" attached to the above mentioned Agreement.
2. The volume of the exchange of goods for the year 1967 shall be based on the actual volume of trade realized during 1965.
3. Both Governments shall endeavour to increase the volume of trade in 1967 by 20 per cent of the target of trade as specified in the Protocol on the Exchange of Goods for the year 1965.
4. The Protocol does not preclude the import and export of other commodities not mentioned in the said lists.
5. The competent authorities of both parties will grant the necessary licences as well as the exchange permits for the implementation of the import and export between the two countries.
6. This Protocol shall enter into force upon ratification according to the laws and regulations in force in the respective countries.

This Protocol shall be valid from January 1, 1967 until December 31, 1967.

Done and signed in Beograd on September 29, 1966, in two original copies in the English language, both copies being equally authentic.
